6	"(1) 1982 Convention.—The term '1982 Con-
7	vention' means the United Nations Convention on
8	the Law of the Sea of 10 December 1982.
9	"(2) Authorized enforcement officer.—
10	The term 'authorized enforcement officer' means a
11	person authorized to enforce this title, any regula-
12	tion issued under this title, or any measure that is
13	legally binding on the United States under the Con-

2	tion Area' means the waters of the Northwest Atlan-
3	tic Ocean north of 35°00' N and west of a line ex-
4	tending due north from 35°00' N and 42°00' W to
5	59°00' N, thence due west to 44°00' W, and thence
6	due north to the coast of Greenland, and the waters
7	of the Gulf of St. Lawrence, Davis Strait and Baffin
8	Bay south of 78°10' N.
9	"(7) COUNCIL.—The term 'Council' means the
10	New England Fishery Management Council or the

19	for any purpose; and
20	"(iii) any operation at sea in support
21	of, or in preparation for, any activity de-

23	"(C) Exclusions.—The term 'fishing ac-
24	tivities' does not include any operation related

1	to emergencies involving the health and safety
2	of crew members or the safety of a vessel.
3	"(10) Fishing Vessel.—
4	"(A) IN GENERAL.—The term 'fishing ves-
5	sel' means a vessel that is or has been engaged
6	in fishing activities.
7	"(B) Inclusions.—The term 'fishing ves-
8	sel' includes a fish processing vessel or a vessel
9	engaged in transshipment or any other activity
10	in preparation for or related to fishing activi-
11	ties, or in experimental or exploratory fishing
12	activities.
13	"(11) Organization.—The term 'Organiza-
14	tion' means the Northwest Atlantic Fisheries Orga-
15	nization provided for by Article V of the Convention.
16	"(12) Person.—The term 'person' means any
17	individual (whether or not a citizen or national of
18	the United States), and any corporation, partner-
19	ship, association, or other entity (whether or not or-
20	ganized or existing under the laws of any State).
21	"(13) Representative.—The term 'Rep-
22	resentative' means a United States Representative to
23	the Northwest Atlantic Fisheries Scientific Council
24	appointed under section 202.

1	"(14) Scientific council.—The term 'Sci-
2	entific Council' means the Scientific Council pro-
3	vided for by Articles V, VI, and VII of the Conven-
4	tion.
5	"(15) Secretary.—The term 'Secretary'
6	means the Secretary of Commerce.
7	"(16) State.—The term 'State' means each of
8	the several States of the United States, the District
9	of Columbia, and any other commonwealth, terri-
10	tory, or possession of the United States.
11	"(17) Transshipment.—The term 'trans-
12	shipment' means the unloading of all or any of the
13	fishery resources on board a fishing vessel to an-
