 - In over 29 years of commissioned service I have had the opportunity to meet challenges across the spectrum of our missions in the field. I have delivered results at the organizational and strategic levels of policy and budget, and have acquired formal training and education to compliment my time in leadership roles both in the field and at staff positions serving with the men and women of the Coast Guard.

In my time as the Assistant Commandant for Prevention Policy I have been responsible for oversight of safety, security and environmental stewardship of our ports, US vessels, foreign vessels calling on the US, US mariners and our waterways.

My 18 years of operations and leadership in the field span the entirety of my career, from junior to senior ranks. I acquired and used an expertise in marine safety; and as a Prevention professional served in positions that interacted directly with all levels of government, industry and the maritime public, including 6 years in command of major shore units. In my operational career, I have responded to hurricanes, oil spills, and marine casualties acquiring an expertise in Response that is crucial to any future operational command at the Flag level.

Our missions and our service as a Coast Guard are vitally important to our Nation's economic and national security interests, and my continued service as a Coast Guard officer is an opportunity that excites and motivates me each day.

19. What do you believe are your responsibilities, if confirmed, to ensure that the department/agency has proper management and accounting controls, and what experience do you have in managing a large organization?

The Coast Guard's enduring roles of safety, security and stewardship highlight the foundational commitment the Coast Guard has to our American public, and has been my career guide. My experience overseeing the GAO/IG audit process in the Coast Guard, as well as my work with Congressional budget/policy requests has indelibly impressed upon me the importance of personal attention to detail in ensuring internal controls are in place and verified.

As a Flag officer I have worked diligently to execute oversight of nearly 1000 employees and a \$30 million operating budget. The formulation and tracking of spending plans, and the corresponding performance plans are the tools I have used to ensure management controls and accountability to our chain of command. Earlier in my career, in formulating the Coast Guard's \$12 billion annual request I was responsible for a process that reached every level of the organization both in the field and at staff offices. That responsibility meant shepherding a coherent strategic approach from the earliest stages of request on through to appropriations in a near 36 month timeline. It included being responsible to not just Coast Guard leadership but to DHS offices as well. Moreover, as a Sector Commander in the field, my area of responsibility included all or part of 10 states with 6 subunits and 6 ships, and 3000 miles of navigable waters. The leadership lessons of balancing competing priorities of stakeholders across vast distances, and taking care of my own Coast Guard team will serve me well in any future role.

20. What do you believe to be the top three challenges facing the department/agency, and why?

Talent Management: We must continue to attract and retain the skilled and diverse workforce that represents the best our country has to offer. For those who aspire to public service we must be among their top choices, and we must give them every reason to stay and grow. This will be most evident in our IT, intelligence and other highly technical fields where we will compete directly with industry for top talent

Data Analytics: Making optimal decisions (fiscally sound, operationally effective) is the fundamental outcome of effective data analytics. To do so we must 'know what we know', i.e. be able to effectively capture, manage and analyze the vast and diverse inputs that drive our Coast Guard, both operationally, and from a policy level. Antiquated IT systems and resource constraints will challenge us to do this effectively.

Cybersecurity: We, like all organizations today, are reliant on a backbone of electronic systems to manage all aspects of what we do. The pace of change in the cyber domain will challenge our workforce and our resources to stay on top of the threats to those systems that come from agile adversaries.

Rear Admiral Richard Timme serves as the Assistant Commandant for Prevention Policy and is responsible for the development of national policy, standards, and programs promoting Marine Safety, Security and Environmental Stewardship. Three Directorates carry out the mission: Inspections and Compliance, Marine Transportation Systems, and Commercial Regulations and Standards. Programs include waterways management, navigation and boating safety, ports and facilities, merchant mariner credentialing, vessel documentation, marine casualty investigation, commercial vessel inspections, and port state control.



He previously served as the Coast Guard's Budget Director where he was responsible for the formulation and justification of the Coast

Guard's \$12 billion budget. Duties included advising senior leadership on all resource issues, and coordinating with DHS, OMB and Congress for budget and resource issues.

His operational experience includes serving as Commander of Coast Guard Sector Ohio Valley where he worked with federal, state and local government agencies to carry out Coast Guard missions. He was also the Captain of the Port and Commanding Officer of Marine Safety Unit Pittsburgh, and during the 2010 DEEPWATER HORIZON oil spill response, served as a Deputy Incident Commander and Federal On-Scene Coordinator Representative.

Additional assignments include program reviewer in the Office of Budget and Programs; Chief of Planning at Marine Safety Office Tampa; Chief of Port Operations at Marine Safety Office Portland, ME; Supervisor, Resident Inspection Office St. Croix, U.S. Virgin Islands; and Marine Inspector at Marine Safety Office New Orleans. He also served as a Deck Watch Officer on the Coast Guard Cutter MELLON, and at the Department of Justice's El Paso Intelligence Center.

Rear Admiral Timme served as a Secretary of Defense Executive Fellow, and holds master degrees from the National War College in National Security Strategy and from the George Washington University in Public Administration. He is a 1991 graduate of the United States Coast Guard Academy where he received a Bachelor of Science in Government. He is a Certified Government Financial Manager (CGFM), and a Coast Guard Type 1 Incident Commander.
