I also have leadership experience assigned to both Department of Defense and Department of Homeland security-led joint/interagency commands and task forces in support of national contingency operations, including the 9/11 terror attacks on the homeland and hurricane Katrina. I led nearly 4,000 Coast Guard Active Duty, Reserve, Civilian and Auxiliary members within the four-state region of the Pacific Northwest as the Thirteenth District Chief of Staff. More recently, I serve as the Military Advisor to the Secretary of Homeland Security. In each of those challenging assignments throughout my career, I provided strategic leadership and guidance, operational direction and administrative oversight of Coast Guard forces in order to accomplish the mission in the most effective and efficient manner possible while addressing the needs of our workforce. As a member of the Coast Guard senior leadership team, if confirmed, I look forward to using my training, experience and knowledge to develop and implement innovative, cost-effective solutions to the challenges we face in ensuring the Coast Guard remains Ready, Relevant and Responsive to the needs of the public.

The Coast Guard will also be challenged to effectively acquire and employ big data and artificial intelligence (AI) systems needed to be competitive and meet mission in an increasingly complex, interconnected world.

I will focus my efforts as a member of the senior leadership team on training, equipping and supporting our men and women so they will remain Semper Paratus – Always Ready – to meet mission. The Coast Guard must understand and be responsive to the needs of our many stakeholders as well if it is to remain relevant in the future. This will be essential as resources continue to be strained as a result of the COVID-19 pandemic and the demand for Coast Guard services continues to grow and evolve as we confront potential threats posed by near-peer competitors.

The Coast Guard will retain and build trust and confidence amongst our many maritime and public stakeholders by pursuing a collaborative approach to solving our most challenging problems through a robust network of interagency, international, state, local, tribal and private industry partners. Finally, the Coast Guard ethos is inextricably linked to our bias for action. The Coast Guard's ability to save lives, enforce our laws, facilitate commerce, respond to disasters and safeguard our ports and waterways is a hallmark of our success. It is our purpose for being and is why we have a Coast Guard. As a member of the senior leadership team, this will be my highest priority.



Rear Admiral Brendan C. McPherson Military Advisor to the Secretary U. S. Department of Homeland Security



Rear Admiral McPherson assumed the duties of the Military Advisor to the Secretary of Homeland Security in June 2019. His primary responsibility is to provide counsel to the Secretary regarding policies, plans, and other affairs between the Department of Homeland Security and the Department of Defense

Rear Admiral McPherson has more than 30 years of service including nearly 12 years cumulative sea time aboard six cutters, including Commanding Officer of cutters MIDGETT, VIGOROUS and BARANOF. Staff assignments included Chief of Staff of the Coast Guard Thirteenth District headquartered in Seattle, Chief of the Response Division (DR) and Chief of the Enforcement Branch (DRE) for the Coast Guard Seventh District in Miami, Press Assistant to the Commandant of the Coast Guard in Washington, D.C., Chief



of Strategic Communications in the Headquarters Office of Governmental and Public Affairs, Public Affairs Officer for the Atlantic Area/Fifth District in Portsmouth, Virginia, and an assignment to the Seventh District Tactical Law Enforcement Team (D7 TACLET) in Miami, Florida.

In addition to his regular duties, Rear Admiral McPherson was assigned to several joint and interagency unified commands in response to national contingency operations. Following the terrorist attacks of September 11, 2001, he was responsible for leading public affairs efforts for all Coast Guard forces within the Atlantic Area and U.S. Maritime Defense Zone Atlantic. In 2002, Rear Admiral McPherson deployed to Joint Task Force Guantanamo Bay, Cuba (JTF GTMO) Joint Information Center in support of Global War on Terror (GWOT) detention operations there. Rear Admiral McPherson also served as Press Secretary to the Principal Federal Official for disaster response and recovery operations in the aftermath of hurricanes Katrina and Rita along the Gulf Coast in 2005.

A native of Bradley Beach, New Jersey, Rear Admiral McPherson graduated with Honors from the U.S. Coast Guard Academy in 1989 with a Bachelor of Science degree in Management.
