7	FORTS.—Section 8931(b)(2) of title 10, United States
8	Code, is amended—
9	(1) in subparagraph (A)—
10	(A) by inserting ", creating," after "identi-
11	fying"; and

1	(B) by inserting "science," after "areas
2	of"; and
3	(2) by striking subparagraph (B) and inserting
4	the following:
5	"(B) soliciting, accepting, and executing
6	oceanographic research and observational
7	projects funded by private grants, contracts, or
8	cooperative agreements that contribute to such
9	goals.".
10	(b) National Ocean Research Leadership
11	COUNCIL MEMBERSHIP.—Section 8932 of title 10, United
12	States Code, is amended—
13	(1) by redesignating subsections (f) through (h)
14	as subsections (g) through (i), respectively;
15	(2) in subsection (b)—
16	(A) by striking paragraph (10);
17	(B) by redesignating paragraphs (11)
18	through (14) as paragraphs (12) through (15),
19	respectively; and
20	(C) by inserting after paragraph (9) the
21	following new paragraphs:
22	"(10) The Bureau of Ocean Energy Manage-
23	ment of the Department of the Interior.
24	"(11) The Bureau of Safety and Environmental
25	Enforcement of the Department of the Interior.";

1	(3) in subsection (d)—
2	(A) in paragraph (2)—
3	(i) in subparagraph (B), by striking
4	"broad participation within the oceano-
5	graphic community" and inserting "appro-
6	priate participation within the oceano-
7	graphic community, which may include
8	public, academic, commercial, and private
9	participation or support"; and
10	(ii) in subparagraph (E), by striking

23	(A) by striking paragraph (1) and insert-
24	ing the following:

1	(1) The Secretary of the Navy shall establish
2	an office to support the National Oceanographic
3	Partnership Program. The Council shall use com-
4	petitive procedures in selecting an operator for the
5	partnership program office. If practicable, an organi-
6	zation or entity may be selected as operator only if
7	the organization or entity has experience managing
8	interagency programs and programs with participa-
9	tion from other public and private entities."; and
10	(B) in paragraph (2)(B), by inserting ",
11	where appropriate," before "managing"; and
12	(7) by amending subsection (h), as redesignated
13	by paragraph (1), to read as follows:
14	"(h) Contract and Grant Authority.—
15	"(1) In general.—To carry out the purposes
16	of the National Oceanographic Partnership Pro-
17	gram, the Council shall have, in addition to other
18	powers otherwise given it under this chapter, the fol-
19	lowing authorities:
20	"(A) To authorize one or more of the de-
21	partments or agencies represented on the Coun-
22	cil to enter into contracts and make grants or
23	cooperative agreements, and establish and man-
24	age new collaborative programs as considered
25	appropriate, to address emerging science prior-

1	ities using both donated and appropriated
2	funds.
3	"(B) To authorize the program office
4	under subsection (f), on behalf of the Council,
5	to accept funds, including fines and penalties,
6	from other Federal and State departments and
7	agencies.
8	"(C) To authorize the program office, on
9	behalf of the Council, to award grants and
10	enter into contracts for purposes of the Na-
11	tional Oceanographic Partnership Program.
12	"(D) To authorize the program office, on
13	behalf of the Council, to solicit, accept and exe-
14	cute oceanographic research projects for pur-
15	poses of the National Oceanographic Partner-
16	ship Program that are funded by private
17	grants, contracts, and donations.
18	"(E) To transfer funds to other Federal
19	and State departments and agencies in further-
20	ance of the purposes of the National Oceano-
21	graphic Partnership Program.
22	"(F) To authorize one or more of the de-
23	partments or agencies represented on the Coun-
24	cil to enter into contracts and make grants, for
25	the purpose of implementing the National

1	Oceanographic Partnership Program and car-
2	rying out the responsibilities of the Council.
3	"(G) To use, with the consent of the head
4	of the agency or entity concerned, on a non-re-
5	imbursable basis, the land, services, equipment,
6	personnel, facilities, advice, and information
7	provided by a Federal agency or entity, State,
8	local government, Tribal government, territory,
9	or possession, or any subdivisions thereof, or
10	the District of Columbia as may be helpful in
11	the performance of the duties of the Council.
12	"(2) Funds transferred.—Funds identified
13	for direct support of National Oceanographic Part-
14	nership Program grants are authorized for transfer
15	between agencies and are exempt from section 1535
16	of title 31, United States Code (commonly known as
17	the "Economy Act of 1932").".
18	(c) Ocean Research Advisory Panel.—Section
19	8933(a)(4) of title 10, United States Code, is amended
20	by striking "State governments" and inserting "State and
21	Tribal governments".
