Given the current mission, major programs, and major operational objectives of the department/agency to which you have been nominated, what in your background or employment experience do you believe affirmatively qualifies you for appointment to the position for which you have been nominated, and why do you wish to serve in that position?

I have extensive experience in both business and government that will serve me well on the CPB Board. Our nation's public television system is a national treasure. But I think its work can be enhanced through deeper partnerships with similar systems internationally. CPB can learn how these international partners – like the BBC – are innovating as media consumption changes, and see how those lessons can assist its work with public television and radio stations here in the U.S. My time as an ambassador, and as a member of various other organizations with international presences, has prepared me well to help CPB with these international relationships.

19. What do you believe are your responsibilities, if confirmed, to ensure that the department/agency has proper management and accounting controls, and what experience do you have in managing a large organization?

The responsibilities of a CPB board member are to make sure that CPB is fulfilling its fiduciary responsibility under the Public Broadcasting Act and complying with all laws. They also are responsible to provide oversight of management to ensure that there is a vibrant, nationwide, public media service.

I would bring a wealth of corporate experience with me to the CPB Board. I have helped manage and run several companies and have held key positions on several boards. As a Board Trustee of the Vermont Studio Center, a non-profit dedicated to supporting artists and writers, I oversaw the selection and education of emerging artists. I value the contributions the arts and humanities make to America. If confirmed, I will use my corporate experience to support the amazing work being done by CPB.

20. What do you believe to be the top three challenges facing the department/agency, and why?

(1) Supporting the Universal Access Mission of Public Broadcasting. CPB has long committed to achieving universal access, both over-the-air and online, to high-quality content. This universal access mission is as important today as ever before, as media consumption habits continue to evolve. These technological changes will test both CPB and public broadcasting stations, and how CPB responds will be important for the future of public broadcasting.

(2) Stability of Funding. CPB relies on Federal funding to support its mission and to assist public broadcasters around the country. This Federal support is important both to help secure programming as well as to make sure that the public broadcasting system can modernize and innovate. Consistent, stable Federal support is a key component to the health of public television and radio.

(3) Diversity of Content. To remain relevant and to achieve its universal access mission, CPB must continue to deliver quality, diverse programming. CPB already has a strong content stream that it supports and distributes to public broadcasters. But with the growth of new national and international content producers, including online video platforms, it will be important for CPB to explore relationships that can bring even more high-quality content onto public television and radio.



- Worked to tackle regional barriers to trade by promoting agreements such as TTIP, currently being negotiated between the European Union and the United States to make it easier to buy and sell goods and services between these two markets.
- Assisted more than 100 U.S. companies with European HQs based in Luxembourg.
- Served as founder and host of the Luxembourg's Forum, a consultative session between the Supreme Court of the United States and the European Court of Justice, which held its first meeting in February 2014.
- Managed a wide range of issues on behalf of the United States, including playing a key role in facilitating compliance with Luxembourg for FATCA, a U.S. law passed in 2010 requiring foreign financial institutions to report on accounts held by U.S. taxpayers. But I think its work can be enhanced through deeper partnerships with similar systems internationally. CPB can learn how these international partners – like the BBC – are innovating as media consumption changes, and see how those lessons can assist its work with public television and radio stations here in the U.S. My time as an ambassador, and as a member of various other organizations with international presences, has prepared me well to help CPB with these international relationships.


