13	SEC. 3. DESIGNATION OF THE UNITED STATES CENTER FOR
14	SAFE SPORT.
15	(a) In General.—Chapter 2205 of title 36, United
16	States Code, is amended by adding at the end the fol-

2	Safe Sport
3	"(a) In General.—The United States Center for
4	Safe Sport (referred to in this subchapter as the 'Center')
5	shall—
6	"(1) serve as the independent national safe
7	sport organization and be recognized worldwide as
8	the independent national safe sport organization for
9	the United States;
10	"(2) exercise jurisdiction over the corporation,
11	each national governing body, and each paralympic
12	sports organization with regard to safeguarding
13	amateur athletes against abuse, including emotional,
14	physical, and sexual abuse, in sports;
15	"(3) maintain an office for education and out-
16	reach that shall develop training, oversight practices,
17	policies, and procedures to prevent the abuse, includ-
18	ing emotional, physical, and sexual abuse, of ama-
19	teur athletes participating in amateur athletic activi-
20	ties through national governing bodies and
21	paralympic sports organizations;
22	"(4) ensure that the policies and procedures
23	under paragraph (3) include requirements that all
24	national governing bodies and paralympic sports or-
25	ganizations follow the policies and procedures of the
26	Center;

1	"(5) maintain an office for response and resolu-
2	tion that shall establish mechanisms that allow for
3	the reporting, investigation, and adjudication of al-
4	leged sexual abuse in violation of the Center's poli-
5	cies and procedures; and
6	"(6) ensure that the mechanisms under para-
7	graph (5) provide fair notice and an opportunity to
8	be heard and protect the privacy and safety of com-
9	plainants.
10	"(b) Policies and Procedures.—
11	"(1) In general.—The Center may, in its dis-
12	cretion, utilize a neutral arbitration body and de-
13	velop policies and procedures to resolve allegations of
14	sexual abuse within its jurisdiction.
15	"(2) Rule of Construction.—Nothing in
16	this section shall be construed as altering, super-
17	seding, or otherwise affecting the right of an ama-
18	teur athlete to pursue criminal or civil justice
19	through the courts.
20	"(c) Limitation on Liability.—
21	"(1) In general.—Except as provided in para-
22	graph (2), the Center, and each national governing
23	body and paralympic sports organization, including
24	any officer, employee, or agent thereof, shall not be
25	liable for damages in any civil action for defamation,

1	libel, slander, or damage to reputation arising out of
2	any action or communication, if the action arises
3	from the execution of the responsibilities or func-
4	tions described in this section, section 220532, or
5	section 220533.
6	"(2) Exception.—Paragraph (1) shall not
7	apply in any action in which the Center, a national
8	governing body, or a paralympic sports organization,
9	or an officer, employee, or agent thereof, acted with
10	actual malice, or provided information or took action
11	not pursuant to this section, section 220532, or sec-
12	tion 220533.
13	"§ 220532. Additional duties.
14	"(a) In General.—The Center shall—
15	"(1) develop training, oversight practices, poli-
16	cies, and procedures for implementation by a na-
17	tional governing body or paralympic sports organiza-
18	tion to prevent the abuse, including emotional, phys-
19	ical, and sexual abuse, of any amateur athlete; and
20	"(2) include in the policies and procedures de-

19	"(i) to share confidentially a report of
20	suspected sexual abuse of an amateur ath-

14	the subject of an allegation of sexual abuse from inter-
15	acting with an amateur athlete.

17	"(a) Records.—The Center shall keep correct and
18	complete records of account.
19	"(b) Report.—The Center shall submit an annual
20	report to Congress, including—
21	"(1) an audit conducted and submitted in ac-
22	cordance with section 10101; and
23	"(2) a description of the activities of the Cen-
24	ter.
