8	towers operating under the Contract Tower Program
9	that—
10	(A) either—
11	(i) had over 200,000 annual tower op-
12	erations in calendar year 2022; or
13	(ii) served a small hub airport with
14	more than 900,000 passenger
15	enplanements in calendar year 2021;
16	(B) are either currently owned by the FAA
17	or are constructed to FAA standards; and
18	(C) operate within complex air space that
19	serves air carrier, general aviation, and military
20	aircraft.
21	(3) Tower selection.—The number of facili-
22	ties selected to participate in the pilot program es-
23	tablished under paragraph (1) shall be determined
24	based on the availability of funds for the pilot pro-
25	gram.

1	(4) CONTROLLER RETENTION.—The Adminis-
2	trator shall appoint to the position of air traffic con-
3	troller all air traffic controllers currently employed
4	by the Federal contract tower operator and assigned
5	to the pilot program air traffic control tower, pro-
6	vided such controller—
7	(A) meets the qualifications contained in
8	section 44506(f)(1)(A) of title 49, United
9	States Code; and
10	(B) has all other pre-employment qualifica-
11	tions required by law.
12	(5) SAFETY ANALYSIS.—
13	(A) IN GENERAL.—The Administrator
14	shall conduct a safety analysis to determine
15	whether the conversions described in paragraph
16	(1) had any negative impact on the aviation
17	safety of any air traffic control tower.
18	(B) REPORT.—Not later than 2 years after
19	the date of enactment of this section, the Ad-
20	ministrator shall submit to the appropriate
21	committees of Congress a report describing the
22	results of the safety analysis under subpara-
23	graph (A).
24	(6) Funding.—For purposes of carrying out
25	this subsection, there are appropriated to the Ad-

1	ministrator \$30,000,000 for fiscal year 2024, to re-
2	main available until fiscal year 2029.
3	(b) AIR TRAFFIC CONTROLLER STAFFING LEVELS
4	AT SMALL AND MEDIUM HUB AIRPORTS:—
5	(1) IN GENERAL.—Section 47124(b)(2) of title
6	49, United States Code, is amended—
7	(A) by striking "The Secretary may" and
8	inserting the following:
9	"(A) IN GENERAL.—The Secretary may";
10	and
11	(B) by adding at the end the following:
12	"(B) SMALL OR MEDIUM HUB AIRPORTS.—
13	In the case of a contract to operate an airport
14	traffic control tower at a small or medium hub
15	airport, the contract shall require the Secretary,
16	after coordination with the airport sponsor and
17	the entity, State, or subdivision, to provide
1.8	funding sufficient for the cost of wages and
19	benefits of at least two air traffic controllers for
20	each tower operating shift.".
21	(2) APPLICATION.—The amendments made by
22	paragraph (1) shall apply to contracts entered into
23	or renewed by the Secretary under the Contract
24	Tower Program on or after the date of enactment of
25	this section.

1	(e) Air Traffic Controller Compensation.—
2	(1) IN GENERAL.—The Secretary and the Sec
3	retary of Labor shall review and update the wage
4	determinations for controllers who work in air traffic
5	control towers that are staffed through the Contract
6	Tower Program and shall reassess the basis for air
7	traffic controller occupation codes and the need for
8	additional occupation codes.
9	(2) REPORT.—Not later than 6 months after
10	the date of enactment of this section, the Secretary
11	and the Secretary of Labor shall submit a report to
12	the appropriate committees of Congress that—
13	(A) describes the findings and conclusions
14	of the review and reassessment made under
15	paragraph (1);
16	(B) explains the basis for the wage deter-
17	mination and the justification for the basis; and
18	(C) describe the steps the Department of
19	Transportation and the Department of Labor
20	are taking to ensure air traffic controller wages
21	are keeping up with inflation and are assigned
22	the appropriate occupation codes.
23	(d) PRIORITIES FOR FACILITY SELECTION.—Section

9	in commercial and military aircraft or
