Given the current mission, major programs, and major operational objectives of the department/agency to which you have been nominated, what in your background or employment experience do you believe affirmatively qualifies you for appointment to the position for which you have been nominated, and why do you wish to serve in that position?

I have over 40 years of executive management experience, including management of a standalone public radio station affiliated with the University of California, and a 26-station public radio network and news operation in Alaska, and as a program manager for a state public broadcasting agency. I was also a volunteer jazz program host at public radio stations in Sacramento and Anchorage, Alaska. At the California Public Broadcasting Commission, I worked with then-Assemblywoman Maxine Waters on development of a public broadcasting minority fellowship program, and with Assemblywoman Gwen Moore on a minority telecommunications conference. I also managed grants for public television and radio stations. In Alaska, I worked with Senator Ted Stevens, when he served on the Senate Commerce Committee, to create legislation to benefit public radio stations that are minority-owned and operated and/or located in rural areas, and specifically for sole service radio stations. As CEO of Alaska Public Radio Network, I was directly involved in the start-up of rural and Native American stations in communities such as Unalakleet, Chevak, Valdez, St. Paul, and Fort Yukon bringing the first radio services to those communities. Through this process and as a grantee, I became familiar with the operations of CPB. I hosted the CPB board of directors on visits to Alaska, accompanying the board to the rural community of Utgiagvik (then called Barrow) and received an honorary citation, as President & CEO of Rasmuson Foundation, for support of public broadcasting. As the principal consultant for Diane Kaplan & Company, I assisted in the funding and development of new public radio stations on the Hopi and Tohono Odham reservations in Arizona and consulted with Tribes in Montana, Minnesota, and Nevada. In my role at Rasmuson Foundation, I oversee grantmaking which includes significant financial support for public broadcast stations in Alaska. I am a personal donor to several stations and, in most years, appear on air during local station fundraisers. As a founding trustee and current member of the board of United States Artists, I've helped to fund and develop a fellowship program for artists, including media artists, with a strong equity lens. Upon my husband's death in 2019, our family created the Mel Sather Media Internship Fund, at the Alaska Community Foundation, which annually funds Alaska Native interns in public radio. We are about to launch our third year of internships.

As a member of the CPB board of directors it would be my responsibility to thoroughly review periodic financial statements and to inquire about any entries that I do not understand or appear to be inconsistent with budget or policy. As part of the orientation process, it is the responsibility of board members to learn about any policies that relate to CPB spending policy and to ensure that those policies are followed.

I served as Treasurer for the national Council on Foundations, Alaska Children's Trust, Philanthropy Northwest (regional association of Grantmakers), Alaska Community Foundation, and am currently Treasurer of United States Artists. I served as Chair of the board of the Alaska Children's Trust and Vice Chair of the Board of the Council on Foundations. I am currently CEO of an \$800

# million (12/31/21) private foundation and serve on its Investment Committee. I am responsible for all operations of the foundation including audit, program, Human Resources, finance, governance, and investments. I have served as CEO since 2001.

The top three challenges facing CPB are: the changing media landscape, public trust in media, and workforce shortages. Public radio and television stations need to be flexible and entrepreneurial to be relevant in the increasingly crowded marketplace of ideas. When public radio and television started, the newspaper industry was robust, ownership of broadcast properties was much less concentrated, and social media did not exist. Today, audiences are dispersed and much harder to capture to deliver programming. Public broadcasters need to adapt new technologies and marketing practices to remain relevant and influential. Research shows that the public increasingly distrusts many of the institutions, like the news media, that used to be trusted to a much greater degree. Rebuilding that trust is essential to future success. Since its inception, public broadcasting has received bipartisan Congressional support for appropriations. In order to remain competitive as an industry of choice, public broadcasting will need to adapt its employment practices to attract high quality people.
