Dear Attorney General Bondi:

I write to raise serious concern that California's newly enacted A.B. 1303 likely violates federal law. Signed earlier this month by Governor Gavin Newsom, A.B. 1303 is the latest in a series of measures by Democrat-run jurisdictions that not only incentivize illegal entry into the United States but also obstruct the lawful operations of federal immigration authorities. By extending state-funded subsidies to individuals who are unlawfully present in the country and by expressly forbidding state agencies from sharing beneficiary information with federal immigration officials, A.B. 1303 appears to contravene 8 U.S.C. § 1373 and the Supremacy Clause of the U.S. Constitution.

Federal law generally bars those in the country illegally from collecting federal benefits.<sup>2</sup> However, state benefits are another matter, and taxpayer-funded giveaways from California continue to drive illegal immigration into the United States. A.B. 1303 amends California law to make "individuals not lawfully present in the United States" — *i.e.*, illegal aliens 4—eligible for California's monthly phone subsidy, Lifeline. Adding insult to injury, A.B. 1303 also prohibits the California Public Utilities Commission (CPUC) and other benefit administrators from sharing beneficiary information with immigration authorities, in apparent violation of federal law.<sup>5</sup>

Illegal entry is not a victimless crime. Illegal immigration fuels human trafficking, child sexual exploitation, and drug smuggling, all of which were rampant under former President Joe

Biden.<sup>6</sup> Under Democrat leadership, Mexican and Venezuelan cartels, as well as other violent gangs like MS-13, have taken root in American cities. Illegal immigration has also exposed the country to a heightened risk of terror attacks. Customs and Border Protection estimates that, since 2021, six to eight million adult men have likely crossed the southern border illegally.<sup>7</sup> For reference, the United States has approximately 1.32 million current active-duty troops.<sup>8</sup>

After suffering the consequences of President Biden's disastrous open-border policies, the American people gave President Trump a decisive victory in the 2024 election, Republican leadership of both houses of Congress, and a mandate to restore the integrity of America's borders. This call to action was reflected in President Trump's signing of the Laken Riley Act, which tightened immigration enforcement by requiring the detention of illegal aliens charged with or convicted of serious crimes; his signing of ten executive orders combatting illegal immigration on the first day of his new term; and in passage of the One Big Beautiful Bill, which invests over \$170 billion to build the border wall and prioritizes the deportation of illegal aliens convicted of violent crimes. Now, illegal crossings along the U.S.-Mexico border have plummeted to their lowest rate in half a century.

Still, Democrats continue to obstruct these reforms. Exhibit A is the "Schumer Shutdown," with Democrats holding the government hostage until Republicans agree to fund healthcare for illegal aliens along with a laundry list of other partisan demands. <sup>13</sup> Meanwhile, Democrat mayors and governors across the country spend untold sums on similar handouts to illegal aliens. In California, Illinois, and Colorado, taxpayers are forced to subsidize illegal aliens' healthcare. <sup>14</sup> In six states—California, Illinois, Maine, Massachusetts, Minnesota, and Washington—illegal aliens receive state-funded food payments. <sup>15</sup> In eighteen states, illegal aliens are eligible for college financial aid, while twenty-two give them in-state tuition breaks despite the latter practice being ruled unlawful by a federal judge. <sup>16</sup> This is in addition to the free

public schools and other public institutions benefiting illegal aliens and their children.<sup>17</sup> And of course, countless jurisdictions have adopted "sanctuary" policies explicitly shielding illegal aliens, many of whom are violent criminals, from federal immigration authorities.<sup>18</sup>

When federal and state law conflict, the Constitution dictates that federal law prevails. <sup>19</sup> And when the federal government lets Democrat-run localities sabotage immigration enforcement, it signals that obstructing federal law is acceptable—even justified. Such thinking has driven a cascade of violent attacks against federal immigration enforcement in recent months, including in Los Angeles, Chicago, and most shockingly in Dallas, where a sniper attempted to murder ICE agents. <sup>20</sup>

Our nation's law enforcement officers, including ICE agents, risk their lives every day to keep Americans safe. It is therefore incumbent upon the Department of Justice to hold states and cities accountable when they encourage illegal entry into the United States and violate federal law. Although the 10<sup>th</sup> Amendment does bar the federal government from "commandeering" the states to enforce federal law, <sup>21</sup> it does not permit states to interfere with or obstruct federal law enforcement. Yet this is precisely what pro-illegal immigration Democrats are doing by enacting laws like A.B. 1303.

I therefore respectfully request that you review A.B. 1303, with a particular eye toward potential violations of 8 U.S.C. § 1373, and take all actions necessary to uphold our country's immigration laws.
