Given the current mission, major programs, and major operational objectives of the Coast Guard, what in your background or employment experience do you believe affirmatively qualifies you for appointment to the position for which you have been nominated, and why do you wish to serve in that position?

I am a Coast Guard officer with 28 years of active duty service. My career to date has two distinct phases, the first portion was operational and the second portion has been mission support. I believe this mix of operational and mission support experience will enable me to lead the Coast Guard at the executive level.

After graduating from the Coast Guard Academy in 1994, I spent my first eleven years planning and executing maritime operations, including almost eight years of sea duty in both the Atlantic and Pacific. I conducted search and rescue, counter drug, migrant interdiction, fisheries enforcement, and maritime security missions.

I spent the next 17 years serving in multiple leadership positions managing the various aspects of planning, programing, budgeting, and executing the Coast Guard's information technology resources. I recently served as the Commanding Officer of the C5I Service Center where my team was the epicenter of the Coast Guard's "technology revolution". We built a culture of innovation that allowed us to deliver technology solutions the Coast Guard needs for mission success.

I am humbled and honored to be nominated for promotion to rear admiral lower half. I love the Coast Guard and have a deep commitment to our people and to our missions. The devotion to duty that our diverse workforce displays every day inspires me to continue to serve. I am extremely proud of the tremendous value the Coast Guard provides to our country. I am eager to leverage my experience and expertise to make lasting contributions to the betterment of the organization as a Coast Guard Flag officer.

21. What do you believe are your responsibilities, if confirmed, to ensure that the Coast Guard has proper management and accounting controls, and what experience do you have in managing a large organization?

Every member of the Coast Guard, regardless of rank or position, has a duty to be good stewards of our resources (people, financial, and operational assets). If confirmed, my responsibility as a Coast Guard Flag officer will be to set unambiguous expectations to follow proper management and accounting controls, clearly communicate my expectations both within the Coast Guard and to our external stakeholders, and measure our performance against the appropriate standards. I served as the Commanding Officer of the C5I Service Center (2019-2022) where I led over 2000 people and was responsible for an annual budget that grew from approximately \$550M to over \$700M. Our personnel were stationed in 27 different locations across the country. Leading this large geographically dispersed staff taught me the importance of managing risk across competing demands for resources, repeatedly engaging and communicating with stakeholders, and providing transparency about our decision-making and performance.

22. What do you believe to be the top three challenges facing the Coast Guard, and why?

Three of the greatest challenges facing the Coast Guard today are: (1) recruiting, training, and retaining a diverse workforce; (2) recapitalizing our operational assets and support infrastructure; and (3) continuing to modernize our C5I capabilities and improving our ability to operate in the domain of cyberspace.

1 – Talent Management. Coast Guard Ready Workforce 2030 and ADM Fagan's Commandant's Intent clearly articulate the need and strategic intent to Transform Our Total Workforce. The Coast Guard's operational success depends on the readiness of our people and the capacity of our workforce. We require a skilled, proficient, and fully supported personnel in each portion of our workforce: active duty, reserve, civilian employees, and Auxiliarists. This includes providing exceptional medical, housing, childcare and other support services for Coast Guard families.

2 – Recapitalization. Demands for the Coast Guard to perform our missions continue to grow, both domestically and around the globe. Properly resourcing the current and planned acquisition programs to provide the cutters, boats, aircraft, and mission support infrastructure will continue to be a difficult challenge. The Coast Guard must work with the administration and Congress to sustain deliberate investments to ensure we have the capabilities required to operate in an increasingly complex world.

3 – The Tech Revolution and Cyberspace Operations. Recent investments in Coast Guard C5I infrastructure have begun to deliver urgently needed technology and capabilities. We must remain committed to this course of action and find better ways to collaborate with industry to leverage their pace of innovation. To be successful, we must dramatically accelerate contracting and acquisition process. Nation states and non-state actors will increasingly contest the operational domain of cyberspace for the foreseeable future. The Coast Guard must be capable of conducting the full spectrum of operations in cyberspace to support our eleven statutory missions.

Russell E. Dash Captain, United States Coast Guard

Captain Rusty Dash was born in Honolulu, Hawaii and is a native of Yorktown, Virginia. He graduated from the United States Coast Guard Academy in 1994 with a Bachelor of Science Degree in Mathematics and Computer Science. Ensign Dash's first assignment was as a Deck Watch Officer onboard the 270 foot Medium Endurance Cutter CAMPBELL (WMEC 909), in New Bedford, Massachusetts.

From 1996-1998, Lieutenant Junior Grade Dash was the Officer in Charge of Law Enforcement Detachment Five Charlie, part of the Tactical Law Enforcement Team North located in Portsmouth, Virginia. During that time, LEDET 5C was deployed onboard U.S. Navy warships to conduct counter-drug operations in the Caribbean and eastern Pacific Oceans, and United Nations sanctions enforcement in the Arabian Gulf.



He reported to the Law Enforcement section of the Atlantic Area and Fifth District staff in 1998, where he planned District-wide law enforcement operations. Lieutenant Dash returned to sea duty in 2001 onboard the 270 foot Medium Endurance Cutter NORTHLAND (WMEC 904), in Portsmouth, Virginia, and he served as the Operations Officer and Navigator. He was subsequently assigned as Commanding Officer of Coast Guard Cutter Washington (WPB 1331), a 110 foot patrol boat in Honolulu, Hawaii, in 2003. Patrolling paradise is arduous duty, but someone has to do it. This was his last afloat assignment.

From 2005-2007 Lieutenant Commander Dash attended the Naval Postgraduate School in Monterey, California where he earned his Master of Science Degree (with Distinction) in Information Systems Technology and won the RADM Grace Murray Hopper Award for outstanding academics and leadership. Following graduate school, he was assigned to Coast Guard Headquarters in the Office of C4 & Sensors Capabilities (CG-761) where he managed requirements for IT systems supporting law enforcement and search and rescue operations. In 2011 Commander Dash transferred to the Atlantic Area staff and served as the Deputy Division Chief of LANT-6. From 2012-2013 he was assigned to the Department of Homeland Security as a Program Manager in the Office of Applied Technology in Washington, D.C..

He returned to the Coast Guard in 2013 and was assigned as Executive Officer at the Command, Control, and Communications Engineering Center in Portsmouth, Virginia. From 2016-2017 Captain Dash attended the National Defense University where he earned a Master of Science degree (Distinguished Graduate) in Government Information Leadership with concentrations in Cyberspace Strategy and Cybersecurity Leadership. After graduating from NDU he reported to CG-6 and became the first Chief of the Office of C5I Program Management (CG-68) in 2018. He assumed command of the C4IT Service Center in May 2019, and became the first C5I Service Center Commanding Officer in June 2020. He transferred to the Personnel Service Center in May 2022 and assumed the duties of Deputy Commander.

Captain Dash's awards include the 2018 CDR John P. Dailey Award for Outstanding Leadership and Mentorship within the Coast Guard C4IT Community, the Legion of Merit, Meritorious Service Medal (3x), Coast Guard Commendation Medal (3x), as well as other personal, unit, and service awards.

He and his wife Danielle are the proud parents of three adult sons. They are also proud part-owners of the Green Bay Packers, winners of 13 professional football championships.
