3 (b) FLIGHT DATA RECOVERY FROM OVERWATER
4 OPERATIONS.—Chapter 447 of title 49, United States
5 Code, as amended by subsection (a), is further amended
6 by adding at the end the following new section:

7 "§ 44746. Flight data recovery from overwater oper8 ations

9 "(a) IN GENERAL.—Not later than 18 months after
10 the date of enactment of this section, the Administrator
11 of the Federal Aviation Administration shall complete a

rulemaking proceeding to require that, not later than 4
 years after the date of enactment of this section, all appli cable aircraft are—

4 "(1) fitted with a means, in the event of an ac5 cident, to recover mandatory flight data parameters
6 in a manner that does not require the underwater
7 retrieval of the cockpit voice recorder or flight data
8 recorder;

9 "(2) equipped with a tamper-resistant method 10 to broadcast sufficient information to a ground sta-11 tion to establish the location where an applicable air-12 craft terminates flight as the result of such an event; 13 and

14 "(3) equipped with an airframe low-frequency
15 underwater locating device that functions for at least
16 90 days and that can be detected by appropriate
17 equipment.

18 "(b) APPLICABLE AIRCRAFT DEFINED.—In this sec19 tion, the term 'applicable aircraft' means an aircraft man20 ufactured on or after January 1, 2027, that is—

21 "(1) operated under part 121 of title 14, Code
22 of Federal Regulations;

23 "(2) required by regulation to have a cockpit
24 voice recorder and a flight data recorder; and

25 "(3) used in extended overwater operations.".

(c) CLERICAL AMENDMENT.—The analysis for chap ter 447 of title 49, United States Code, is amended by
 inserting after the item relating to section 44744 the fol lowing:

"44745, Recording devices. "44746, Flight data recovery from overwater operations.".
