8	tized as Federal flight deck officers under section
9	44921 of title 49, United States Code, as sensitive
10	security information in a manner consistent with the
11	classification of information about Federal air mar-
12	shals; and
13	(2) the Administrator shall revise section
14	1520.5(b)(11) of title 49, Code of Federal Regula-
15	tions, to classify information about pilots deputized
16	as Federal flight deck officers under section 44921
17	of title 49, United States Code, as sensitive security
18	information in a manner consistent with the classi-
19	fication of information about Federal air marshals.
20	(j) Regulations.—Not later than 180 days after
21	the date of enactment of this Act, the Administrator shall
22	prescribe such regulations as may be necessary to carry
23	out this section and the amendments made by this section.
