4 (a) IN GENERAL.—Section 41733 of title 49, United
5 States Code, is amended by adding at the end the fol6 lowing new subsection:

7 "(i) Community Petition for Review.—

8 "(1) PETITION.—An appropriate representative 9 of the community in which an eligible place is lo-10 cated may submit to the Secretary a petition ex-11 pressing no confidence in the air carrier providing 12 basic essential air service under this section and re-

1	questing a review by the Secretary. A petition sub-
2	mitted under this subsection shall demonstrate that
3	the air carrier—
4	$(\Lambda)$ is unwilling or unable to meet the
5	operational specifications outlined in the order
6	issued by the Secretary specifying the terms of
7	basic essential air service to the community;
8	"(B) is experiencing reliability challenges
9	with the potential to adversely affect air service
10	to the community; or
11	"(C) is no longer able to provide service to
12	the community at the rate of compensation
13	specified by the Secretary.
14	"(2) REVIEW.—Not later than 2 months after
15	the date on which the Secretary receives a petition
16	under paragraph (1), the Secretary shall review the
17	operational performance of the air carrier providing
18	basic essential air service to the community that
19	submitted the petition and determine whether the
20	air carrier is fully complying with the obligations
21	specified in the order issued by the Secretary speci-
22	fying the terms of basic essential air service to the
23	community.
24	"(3) TERMINATION.—If based on a review
25	under paragraph (2), the Secretary determines non-

1	compliance by an air carri <mark>e</mark> r with an order specifying
2	the terms for basic essential air service to the com-
3	munity, the Secretary may—
4	"(A) terminate the order issued to that air
5	carrier; and
6	"(B) issue a notice under subsection (c)
7	that an air carrier may apply to provide basic
8	essential air service to the community for com-
9	pensation under this section and select an ap-
10	plicant under that subsection.
11	"(4) Continuation of service.—If the Sec-
12	retary makes a determination under paragraph (3)
13	to terminate an order issued to an air carrier under
14	this section, the Secretary shall ensure continuity in
15	air service to the affected community.".
