Over the course of my 27 years of service in the Coast Guard, I have had the honor of serving in key assignments that have broadened my operational acumen and advanced my leadership experience.

I currently serve as the Executive Assistant to the Vice Commandant. In this role, I operate as his direct representative on all matters pertaining to the

administration and management of the Coast Guard. Prior to this assignment, I served as Commander, Sector New Orleans - one of the Coast Guard's largest sector commands. Of note, during this tour of duty, I served as Coast Guard Incident Commander for Hurricane Ida Response and Recovery Operations.

Prior operational tours include serving as Commanding Officer at Marine Safety Unit Lake Charles, Louisiana, as Executive Officer at Marine Safety Unit Texas City, Texas and as Executive Officer at Marine Safety Unit Cleveland, Ohio. I also deployed to Joint Field Office Baton Rouge in support of Hurricanes Katrina and Rita Rescue and Recovery Operations in 2005.

Several staff assignments and educational opportunities have provided me vital exposure to governmental/interagency inner-workings and enterprise level leadership. Those include serving as Senior Military Assistant to the Secretary of Homeland Security, as a Coast Guard Congressional Affairs Liaison, graduate of the National War College and Fellow of the Massachusetts Institute of Technology Seminar XXI on Foreign Politics, International Relations and the National Interest.

Above all, the Coast Guard has afforded me the opportunity to serve with the incredible men and women that comprise its ranks. I am energized daily by the great work that our Coast Guard is doing to protect our citizens, our ports, our waterways, and our way of life. If I am confirmed, I look forward to serving at the next level of leadership in our organization. I count it an honor and a privilege to lead within the world's best Coast Guard as we serve this Nation amidst increasingly complex and challenging mission demands.

21. What do you believe are your responsibilities, if confirmed, to ensure that the Coast Guard has proper management and accounting controls, and what experience do you have in managing a large organization?

Every leader has a responsibility to be a good steward of the resources within his or her span of influence. Accountability, transparency, honor and integrity are key elements of that effort, in my view. To that end, I will continue to ensure that the resources within my charge are monitored effectively to prevent misuse and are employed effectively to maximize mission execution. I have done so throughout my career, both in major command cadre and key leadership and oversight roles.

From 2018-2022, I served as Deputy Commander, and subsequently, Commander of Sector New Orleans, one of the Coast Guard's largest Sector Commands. The unit had over 750 personnel attached with 17 subordinate units spread throughout Southeast Louisiana, including 6 cutters (4 patrol boats, 2 construction tenders), 3 small boat stations, 4 Aids to Navigation Units, 3 Marine Safety Units, and 1 Marine Safety Detachment. In this position, I was charged with oversight of a \$2.7 million dollar annual budget, judiciously employed to support vital safety and security operations in one of the Nation's most vital economic centers.

I was also privileged to serve as Military Assistant to the Secretary of Homeland Security from 2015-2017. There, I gained great exposure to Cabinet-level leadership at one of the government's largest federal executive departments. In my current role as Executive Assistant to the Vice Commandant, I serve as his direct representative on all matters related to the operation and administration of the Coast Guard.

22. What do you believe to be the top three challenges facing the Coast Guard, and why?

Recruiting talent is one of the Coast Guard's leading concerns. Coast Guard mission demands are proving increasingly challenging and complex. As maritime commerce, trade and transport increase, the requirements to keep our waterways safe and secure grow. We need a well-trained and ready workforce to meet the increasing demand. Presently, we are seeing a decline in the number of people willing to serve. The Coast Guard is working diligently to resolve this issue.

Another key challenge is that of keeping pace with the ever changing and increasingly complex maritime operating environment. Larger and more technologically advanced ships, unmanned autonomous vessels, the proliferation of automation in our ports, and an increasing number of waterway users overall within the Marine Transportation System (MTS) are several, among many other factors, the service must consider as we work to ensure maritime safety and security along our ports and waterways. Resourcing, training, and equipping our people to keep pace with this rapid change requires innovation, creative engagement and vital partnerships.

Last, but certainly not the least of these, is the challenge presented by cyber proliferation/influence within the MTS. Our Nation's critical maritime infrastructure is increasingly more modernized and digitally interconnected through the cyber realm. This presents risk that we must understand, monitor, and mitigate to ensure maritime commerce continues to move along the MTS safely and efficiently. We must also continue to protect Coast Guard systems from cyber intrusion and disruption.

Captain Watson currently serves as Executive Assistant to the Vice Commandant. In this role, he operates as the Vice Commandant's direct representative on all matters pertaining to the administration and management of the Coast Guard. Prior to this assignment, Captain Watson served as Commander, Sector New Orleans where he directed all Coast Guard missions in an area of responsibility that includes the Louisiana Gulf Coast and the Mississippi River System from Baton Rouge to the Gulf of Mexico out to the U.S. Outer Continental Shelf - among the largest, busiest and most complex coastal and port areas in the United States. Of note, during this tour of duty, Captain Watson served as Incident Commander for Hurricane Ida Response and Recovery Operations following the catastrophic impacts

of one of the most powerful hurricanes to ever make landfall on the U.S. mainland.

Captain Watson's previous operational tours include serving as Commanding Officer at Marine Safety Unit Lake Charles, Louisiana, from 2012 to 2015 where he oversaw maritime safety, security, and environmental response missions throughout Southwest Louisiana. From 2010 to 2012, he served as Executive Officer at Marine Safety Unit Texas City, Texas with oversight of operations throughout the ports of Galveston, Texas City and Freeport, Texas. He also served as Executive Officer at Marine Safety Unit Cleveland, Ohio from 2005 to 2007 and deployed to Joint Field Office Baton Rouge in support of Hurricanes Katrina and Rita Rescue and Recovery Operations in 2005.

Captain Watson's staff assignments include serving as Senior Military Assistant to the Secretary of Homeland Security from 2015-2017, as Congressional Affairs Liaison from 2007-2010 and as the Eighth District Budget Officer from 2001-2005.

Captain Watson holds a Master of Science in National Security Strategy from the National War College in Washington, D.C., a Master of Business Administration from Loyola University, New Orleans, Louisiana, as well as a Master of Arts in Education and a Bachelor of Science in Biology from Xavier University in New Orleans, Louisiana. Captain Watson is a 2016-2017 Fellow of the Massachusetts Institute of Technology Seminar XXI on Foreign Politics, International Relations and the National Interest.
