I have been selected for promotion through the service's structure based on merit, through proven performance. I wish to serve as a Flag Officer in the Coast Guard to continue to provide value and positive impact to the service.

My responsibilities will include ensuring that all required management and accounting controls are appropriately followed. I have over 28 years of service as an officer in Coast Guard, including serving as the Coast Guard Seventeenth District Chief of Staff. In this capacity I supervise and coordinate the budgetary program, analyze and review administrative procedures and practices, and administer the District's records management program, among other responsibilities.

Acquisition/operationalization of new assets: In order to operationalize new Coast Guard assets (ships, aircraft etc.), the service must have the shore-based infrastructure, personnel, support systems (training, administrative functions, housing, child care, etc.) in place to enable them to successfully execute their missions.

In 2012, while I was assigned as the Executive Officer of Air Station Borinquen, Puerto Rico, a civilian employee filed a formal complaint alleging harassment and hostile work environment on the bases of race (African-American), color (black), age (over 40), and in reprisal for prior EEO activity, when in 2011 he was placed on administrative leave pending outcome of investigation for threatening to harm a management official. Claimant appealed to Merit Systems Protection Board which upheld the suspension. In July 2013, the Department of Homeland Security Office of Civil Rights and Civil Liberties issued a Final Agency Decision that the Complainant failed to prove discrimination. In June 2015, the Equal Employment Opportunity Commission affirmed the Department's Final Agency Decision.

In 2016, while I was the Commandant of Cadets at the Coast Guard Academy, a First Class Cadet submitted a whistleblower complaint to the Office of Inspector General alleging that adverse personnel actions were reprisal for his involvement as a witness in a sexual assault investigation involving another cadet. I took the First Class Cadet to Cadet Mast based upon charges of intoxication and attempt to deceive based upon prior interviews in the sexual assault investigation. I found him not guilty. The Cadet received his degree and commission from the Academy and withdrew his OIG complaint.

In 2017, as the Commandant of Cadets at the Coast Guard Academy, I recommended termination of a First Class Cadet's (graduating Senior) appointment after finding him guilty at Cadet Mast for having a consensual but inappropriate intimate relationship with a female Fourth Class Cadet (a Freshman). The Cadet's appointment was terminated. Alleging gender bias, the Cadet applied to the Department of Homeland Security Board for Correction of Military Records (BCMR) to overturn his disenrollment and that he be graduated and commissioned. In 2018, the BCMR denied relief stating that the Cadet abused his authority and committed numerous violations of Academy rules.

In February of 2019, the Coast Guard Academy investigated whether a First Class Cadet experienced bullying and harassment or discrimination based upon race (African American) when the Cadet was placed on Suitability for Service Probation. I have been informed that the investigation found that allegations of bullying and harassment were unsubstantiated but that the cadet may have experienced unintentional disparate treatment when he was placed on probation while a Caucasian member of his company with a similar record was not. At the time, I was the Commandant of Cadets. I was not involved in the decision to place the Cadet on Suitability for Service Probation, which decision fell to his Company Officer, a Lieutenant Commander. I have also been informed that since the cadet was removed from Suitability for Service Probation in 2017, completed his degree, and received his commission in 2019, it was determined that the cadet was made whole through actions taken by the chain of command. The Cadet never filed an EEO complaint.

In 2019, while serving as the District Seventeen Chief of Staff, an employee alleged discrimination based upon his race and national origin (Native American) when his supervisor did not authorize him to update Coast Guard training materials that he felt contained inaccurate stereotypes about Native Americans. At that time, the employee was serving as a Coast Guard liaison to Native American tribes in Alaska. Additionally, the employee claimed he was not promoted in 2018 after becoming eligible, claimed that he was restricted to traveling between 0800 and 1600, and that he received a letter of reprimand as reprisal when he informed the unit that he intended to file an EEO complaint. I became his second level supervisor in July 2018. Subsequently, the employee applied for and was selected for a different federal position with the Coast Guard and I am now his fourth level supervisor. I provided a statement to the EEO investigator addressing my knowledge of the claims raised by the Complainant. The case is still open and subject to updates.

In February of 2019, while I was serving as the District Seventeen Chief of Staff, a civilian employee filed an anti-hate/harassment incident (AHHI) complaint based on reprisal for prior EEO activity, for acting as a whistleblower, and reprisal for her expressed opposition to discrimination. I was her second level supervisor and was named as one of four responsible parties in the complaint. District Seventeen conducted an administrative investigation that determined in April 2019 that the claims were unsubstantiated.

In July of 2019, the same civilian employee filed a formal complaint on the bases of sex (female), age (over 40), and reprisal for previous EEO activity, alleging she was provided fewer training opportunities than a male coworker, she was reassigned work spaces, she received an inaccurate annual performance evaluation for the 2018-2019 rating period, and she was not allowed to attend work-related coordination calls. Following her reassignment, I became her third level supervisor. The Report of Investigation and election letter were issued on September 30, 2019. Her case is pending receipt by the Civil Rights Directorate at Coast Guard Headquarters of her election of either a hearing by an EEOC Administrative Judge or a Final Agency Decision without a hearing.






Captain Melissa Rivera currently serves as the Chief of Staff for the 17th Coast Guard District. Headquartered in Juneau, Alaska, the men and women of the 17th District conduct all 11 of the Coast Guard's statutory missions in an area encompassing nearly four million square miles of the Pacific and Arctic Oceans including the Bering Sea.

Capt. Rivera most recently served as the Commandant of Cadets at the U.S. Coast Guard Academy. In that position, she was responsible for the professional and leadership development of the Corps of Cadets, developing leaders of character worthy of commissions as officers in the U.S. Coast Guard.

Capt. Rivera is a career aviator and has an extensive history of service in Alaska including two tours at Air Station Kodiak and one tour at Air Station





During a tour at Coast Guard headquarters, Capt. Rivera was the first Aviation Special Missions Manager. In this capacity she developed aviation counter-terrorism policy while coordinating development, operational testing and mission employment of tactical aviation capabilities. She also served as Executive Officer at Air Station Borinquen, Puerto Rico, flying the MH-65 Dolphin helicopter.

After graduating from Naval Flight Training in Pensacola, Florida, as CG Aviator #3251 on Aug. 4, 1995, Capt. Rivera's first operational aviation assignment was to Air Station Elizabeth City, North Carolina, where she flew the HH-60J helicopter. In the aftermath of Hurricane Floyd in 1998, she commanded one of the first helicopters on scene and executed night rescues of 43 survivors trapped by rising floodwaters in Eastern North Carolina.

Capt. Rivera graduated from the U.S. Coast Guard Academy in 1991 with a Bachelor of Science in Government. After graduation she served as a deck watch officer aboard the USCGC VENTUROUS in Long Beach, California

She earned a Master of Arts degree in National Security and Strategic Studies from the Naval War College, graduated from the College of Naval Command and Staff with distinction and earned a Certificate in Homeland Security Studies from the National Graduate School.

Capt. Rivera was born in Galesburg, Illinois and raised in Kent, Washington. Her personal military awards include five Meritorious Service Medals, two Air Medals, two Coast Guard Achievement Medals and an Army Achievement Medal. She is married to retired Coast Guardsman Epy Rivera and has two daughters.
