Whether updating the Coast Guard's desktop computer system to take advantage of the latest software solutions or modernizing the Coast Guard's fleet with tomorrow's technology, the Coast Guard must be able to continuously evaluate technological advances and incorporate these improvements to address future demands for service. The Coast Guard must also regularly review tactics, training and procedures to ensure the workforce is prepared to most effectively meet these emerging demands of a technology dependant economy.

The Coast Guard is uniquely positioned and must continue to leverage the full set of our authorities, capabilities, and partnerships to meet increasing service demands. In 2004, when I was a lieutenant commander, I was named as an alleged discriminating official in an EEO case. A military member who was leaving the service alleged discrimination based on race and gender when she was not selected for a civilian Port Security Specialist position. I was named because I had been directed to serve on the hiring panel for the open position and interviewed the complainant and another candidate. The other candidate was ultimately selected for the position by my superior because of his qualifications and extensive experience in the field. I did not serve as the supervisor of the complainant. After trial on the merits, the Coast Guard was found to not have discriminated in any way against the complainant.

Captain Wayne R. Arguin Jr. Director, Inspections and Compliance (CG-5PC)

Captain Arguin currently serves as the Director of Inspection and Compliance within the Prevention Policy Directorate at U.S. Coast Guard Headquarters. Captain Arguin is responsible for policy development and program oversight of foreign and domestic commercial vessel, port and facility safety and security, recreational boating safety, vessel documentation, marine casualty investigations and the United States Coast Guard Auxiliary.

His previous operational assignments include Sector Commander in New Orleans, LA where he directed Coast

Guard operations throughout the Louisiana and Mississippi Gulf Coast as well as the Mississippi River System from Baton Rouge to the Gulf of Mexico and U. S. Outer Continental Shelf. As Executive Officer of Marine Safety Office Memphis, TN and Prevention Department Head at Sector Lower Mississippi River, he coordinated waterways management activities, vessel inspections, mariner licensing and marine casualty investigations on the Lower Mississippi River and its tributaries. In 1994, Captain Arguin earned his Marine Inspection qualifications at Marine Safety Office Hampton Roads and served as senior marine inspector performing commercial vessel and cruise ship inspections at Marine Safety Office Tampa, Florida. He was also assigned to USCGC HARRIET LANE (WMEC-903) as a student engineer, deck watch officer and Damage Control Assistant.

His staff assignments include Director of Emerging Policy, where he was responsible for the development of enterprise strategy/doctrine to address emerging national priorities impacting Coast Guard interests. He also led the Coast Guard's strategic foresight initiative, Project Evergreen, a multi-year process to identify strategic service needs through 'over the horizon', scenario-based planning methods. Captain Arguin served at the Coast Guard's Marine Safety Center where he was responsible for the evaluation and approval of vessel structures, stability, fire protection systems and coordinated salvage engineering support to the Coast Guard Captains of the Port (COTP) in response to a variety of vessel casualties. In 2008, he was assigned to the Executive Staff of the Deputy Commandant for Operations, serving as the Staff Director for the National Incident Commander throughout the Coast Guard's historic response to the Deepwater Horizon casualty, supporting daily White House and Cabinet-level briefings on the Nation's response effort. In 2001, Captain Arguin was assigned to Coast Guard Headquarters, Office of Design and Engineering Standards where he developed domestic and international design standards for high speed, novel craft and coordinated the Coast Guard's Risk Based Decision-Making initiative.

Captain Arguin is a 1992 graduate of the Coast Guard Academy, where he earned a Bachelor of Science degree in Naval Architecture and Marine Engineering and in 2001, he earned a Master of Science degree in Naval Architecture and Marine Engineering from the University of Michigan.
