Yes, in two instances. The first case was Robert Barrientos v. The Curators of the University of Missouri, Radio Station KCUR, Patricia Cahill and James Costin, Case No. 16CV95-15377, alleging sex and national origin discrimination and breach of contract. The case was filed in the Circuit Court of Jackson County, Missouri on July 26, 1995. On June 24, 1996, the case was dismissed with prejudice after the parties reached a settlement. The defendants expressly denied liability, but the University of Missouri agreed to pay plaintiff \$10,000 in exchange for a stipulated dismissal with prejudice.

In the second instance, an employee of the radio station I managed at the University of Missouri-Kansas City complained to the University Affirmative Action Office of discrimination on the basis of sex by the radio station's Program Director in September, 2010. I received a letter from the university investigator in February, 2011 stating no discrimination was found to have occurred by me or the Program Director.
